

Dear Homeowner,

As required by the Idaho State Legislation actions 55-116 and 55-1507, the Century Farm Owners Association, Inc. must provide the following 2023 Disclosure of Fees:

- 1. Assessments for the Association are billed annually in January in the amount of \$600.00.
- 2. Late Fees are \$25.00 per billing and interest may accrue at an annual rate of 12% if any assessment becomes past due.
- 3. Setup Fees are one-time fees in the amount of \$250.00, paid by the first owner of a property.
- 4. Transfer Fees are fees paid at the time of each change in owners of a property in the amount of \$150.00.
